

CREDIT/DEBIT CARD AUTHORIZATION CASH BONDS

The Court will hold the cash bond until the final adjudication of your case. Any fines, fees and/or court costs assessed on your case will be deducted from the cash bond and the balance, if any, will be refunded **by mail** after the said final adjudication date. You will be responsible for any additional fine/court costs not covered by the cash bond. If you fail to appear in court, the cash bond will be forfeited and a warrant issued for your arrest.

Effective 6/21/12, the Court must collect one \$35.00 Bail Bond Filing Fee per arrestee (Act 2012-535). The Bail Bond Filing Fee is not part of a cash bond and is not subject to refund or application to fine/court costs.

All debit/credit card transactions are assessed a **4.5% Service Fee** by **Municipal Pay Services AL**. A receipt will be provided at the completion of the transaction. The Service Fee is not part of the cash bond, is not subject to refund or application to fine/court costs, and is not revenue for the City of Orange Beach. ***Be advised that if your charge is declined for any reason, the 4.5% service fee for the amount you entered will still be collected by the on-line provider.***

NOTICE TO THE DEFENDANT

State law prohibits magistrates from receiving pleas of guilty from anyone convicted of two or more traffic offenses in the preceding 12 months. *If you have been convicted of two or more traffic offenses within the preceding 12 months, do not sign this plea of guilty. A false statement will subject you to penalties prescribed by law.*

PLEA OF GUILTY - WAIVER OF RIGHTS

YOU ARE HEREBY ADVISED OF YOUR RIGHTS AS A DEFENDANT IN THIS TRAFFIC CASE.

Please Read Carefully

I, the undersigned, do hereby enter my appearance on the offense charged within this complaint. I understand that I have certain constitutional rights which I will waive if I plead guilty, namely: the right to a trial before this court; the right to an attorney of my choice, or if I cannot afford one, one appointed by the court (however, I understand that I may be ordered to make reimbursement at a later date); the right at trial to subpoena witnesses on my behalf, to confront and cross-examine witnesses against me and to argue and make objections; and the right to testify in my own behalf. I also understand that I cannot be forced to testify against myself and that I am presumed innocent and that this presumption can be overcome only if the prosecution convinces the judge or jury of my guilt beyond a reasonable doubt.

I understand my constitutional rights set out above and the punishment that will be imposed if I elect to plead guilty before a magistrate. I also understand that my plea of guilty will have the same force and effect as a judgment of conviction by the court and that a record of this conviction will be sent to the driver license division of the Alabama Department of Public Safety (or of the state where I received my license to drive). This may result in the suspension or revocation of my driver's license and may adversely affect my ability to maintain or secure automobile insurance. I further understand that this conviction may result in enhanced penalties on subsequent convictions. I understand my rights and the matters set out above and hereby voluntarily and knowingly waive such rights by pleading guilty as evidenced by my signature below. I further state under penalty of law (Section 13A-10-109, Code of Alabama 1975), that I have not been convicted of two or more traffic violations during the preceding twelve months.
